HENDERSON COUNTY PUBLIC LIBRARY DISTRICT BOARD OF TRUSTEES REGULAR BOARD MEETING THURSDAY, MARCH 14, 2024

CALL TO ORDER: 8:00 AM.

ROLL CALL: Present- Eric Hoey, Nibby Priest, Tiffany Sights, Elizabeth Quick and Arlene Alexander via Zoom. Also, Present-Shannon Sandefur, Library Director; Tammy DeKemper, FIN/HR Mgr.; Davis Hunter, Library Attorney; Glenn Riggs, Library Genealogy and Local History Manager; Connor Humphrey, Curator of John James Audubon State Park Museum; Heidi Taylor-Caudill, former Curator of John James Audubon State Park Museum via Zoom; and David Oppenheimer of J. Oppenheimer Gallery of Chicago via Zoom.

PUBLIC COMMENT: None

BIRDS OF AMERICA PRINTS DISCUSSION & QUOTES: This discussion is a continuation from the previous monthly board meeting. Glenn spoke of how the library would like to have the Birds of America prints in the best shape possible through an archivally and conservation standpoint. Heidi Taylor-Caudill, spoke on the history of the prints and gave a summary about the Havell prints. She said the loose prints were very rare and the library had a treasure. David Oppenheimer worked with his father for 20 years buying, selling, and restoring Audubon prints. The treatment that was done in 1991 on ten of the library's prints at J. Oppenheimer Gallery were fairly standard treatments for works of art on paper. They were addressing acid issues, foxing, and surface cleaning. It depends on the environment the prints are in as to how long the treatment last. He stated he would need to look at the prints to access the current conditions. He could look at images or he could examine them in person if we ship them to him. The primary tenets of their conservation are to only do what is necessary.

Glenn explained to the board how Inman's Picture Framing and Bippus Frames would evaluate the prints after receiving them and unframing. Inman's has two conservators in California that they use and Bippus uses Snodgrass and Davis Studio in Indianapolis. Oppenheimer is the group that did the previous work in 1991. Oppenheimer is an all-encompassing company doing the work. Conner Humphrey stated that there were videos about the conservation process by the Oppenheimer Gallery that show hinging the prints and other processes if you would like to see more information. Conner recommends keeping it all within the same company. Audubon has used Oppenheimer in the past. He would have to research to see if there were others, but it is good to use someone who has experience with Audubon prints.

 Nibby Priest made a motion to direct the staff to work with Oppenheimer to get estimate to restore and reframe the Birds of America Prints. Second, Elizabeth Quick. CREDIT/DEBIT CARD TRANSACTIONS PROCEDURE: Shannon just reviewed and made current.

Elizabeth Quick made a motion to accept the procedure as written. Second, Tiffany Sights.

DONATIONS OF MATERIALS POLICY: Shannon reviewed and updated since it hasn't been changed since 2005. She removed some of the items to make it more streamlined.

Nibby Priest made a motion to accept the policy as written by staff. Second, Elizabeth Quick.

2024 SANDY LEE SONGFEST: We have applied to be a venue for the Sandy Lee Songfest this year. The Board needs to give them permission to sell tickets because this is a fundraiser.

Nibby Priest made a motion to approve the Sandy Lee Songfest be able to sell tickets if we
are selected as venue per the meeting room policy. Second, Arlene Alexander. All aye.

SOLAR ECLIPSE: Shannon would like the ability to cease services for approximately one hour to allow the staff to be able to experience the once in a lifetime solar eclipse.
